The Board asked Clerk's Office for an accounting procedure recommendation to be presented at the next Budget Work Session (on 3-1-18). Supervisor Ramey called for a short break.

The break began at 3:03 p.m. The meeting resumed at 3:19 p.m.

The Board discussed the funding of line items Drain-Tax-At-Large, including Mud Creek Drain/interest payment, and Road Maintenance. Trustee Lazet requested Supervisor Ramey to obtain an updated *Suggested Local Roads Project* list for Vevay Township from William Conklin, Director of the Ingham County Road Department.

Trustee Lazet requested additional information regarding the Douglas & Tami Shaw's miscellaneous receivables account prior to the meeting with the Shaw's. Information is to include files, escrow accounts, fee schedules and any other pertinent information.

The Board worked until 4:47 p.m., completing the line items in general fund 101. Two of the line items will be reviewed again at the next Budget Work Session.
