ORDINANCE NO. 32.03

PREAMBLE

AN ORDINANCE TO AMEND ORDINANCE NO. 32, THE SAME BEING AN ORDINANCE PURSUANT TO PA 1951, NO. 33, AS AMENDED, BY PA 1990, NO. 102 (MCL 41.806a) TO PROVIDE A BASIS FOR AND COLLECTION OF FEES FOR FIRE PROTECTION SERVICES PERFORMED WITHIN THE TOWNSHIP; TO PROVIDE FOR POLICIES AND MODIFICATION OF FIRE PROTECTION SERVICES FEES BY RESOLUTION OF THE TOWNSHIP BOARD; TO AMEND THE DEFINITION OF "FIRE PROTECTION SERVICES"; TO PROVIDE A SAVINGS CLAUSE; TO REPEAL CONFLICTING ORDINANCES; AND TO PROVIDE AN EFFECTIVE DATE HEREOF.

The Township of Vevay, Ingham County, Michigan, hereby ordains this Amendment to Ordinance No. 32, that shall be and is hereby amended to strike-out language and add **amending language**, as follows:

SECTION 1. AMENDMENT OF SECTION 1, "ESTABLISHMENT OF FEES." Section 1, "Establishment of Fees," shall be and is hereby amended as follows:

- A. **DEFINITION.** "Fire protection services" within the context of this Ordinance shall include all responses of fire service providers on behalf of the Township, to include but not limited to, responses to motor vehicle accidents, to investigate fire alarms, carbon monoxide, smoke and similar detection equipment; and respond to fires, prevent fires, explosions and the spread of fire from one place to another, gas leaks, and the response of emergency personnel in connection therewith.
- B. **ESTABLISHMENT OF FEES.** There is hereby established policies and fees, of which may be established, amended and modified, from time to time by Resolution of the Vevay Township Board of Trustees, to be charged to any person or persons, corporations or other entities receiving fire protection services within the Township of Vevay, shall remit to Vevay Township the established costs thereof.

Said fees are established to defray the cost of fire protection services and to reimburse the Township for the provision of fire protection services and expenses incurred as a result of fire protection services provided, including but not limited to, the cost of operating and housing equipment, labor and/or contracting for fire protection by the Township.

SECTION 2. AMENDMENT OF SECTION 1, "CALCULATION OF FEES." Section 2, "calculation of Fees," shall be and is hereby amended as follows:

Sec. 2. The Township will invoice the costs and fees of the fire protection services to any person or persons, corporations or other entities receiving fire protection services within the Township of Vevay as provided in Section 1.

SECTION 3. AMENDMENT OF SECTION 3, "MODIFICATION OF FEES AND CHARGES." Section 3, "Modification of Fees," shall be and is hereby deleted and modification of fees and charges added to Section 1 of this Amending ordinance and therefore deleted from Section 3 as follows:

SECTION 4. SAVINGS CLAUSE.

All other provisions of Ordinance No. 32 not amended by this Ordinance shall remain in full force and effect. All proceedings pending and all rights and liabilities existing, or incurred at the time this amendatory ordinance takes effect are saved and may be consummated according to the law in force when they are commenced. This amendatory ordinance shall not be construed to affect any prosecution pending or initiated before the effective date of this amendatory ordinance, or initiated after the effective date of this amendatory ordinance for an offense committed before that effective date.

SECTION 5. CONFLICTING ORDINANCES REPEALED.


Any Vevay Township ordinances or parts of ordinance in conflict or inconsistent with any of the provisions of this article are hereby repealed.

SECTION 6. SEVERABILITY.


If any section, paragraph, clause, phrase, or part of this ordinance is held invalid by any court of competent jurisdiction, or by any agency, department, or commission empowered by statute for such purposes, such decision shall not affect the validity of the remaining provisions of this ordinance, and the application of those provisions to any person or circumstances shall not be affected thereby.

SECTION 7. EFFECTIVE DATE.

This Ordinance shall become effective May 1, 2021, after its adoption and publication as provided by law.
