Public Comment. None.

The Recreation Commission celebrated with cookies, provided by Chair Cargill, the award of \$150,000 MDNR Recreation Passport Grant. This grant award is the first phase in the implementation of the Recreation Master Plan. Supervisor Lazet expressed his appreciation to the Recreation Commission. This is the "first" development grant the Township has ever received.

Recreation Passport grant project procedures including plans, specifications and bid documents, contractor selection, funding and reimbursement, and a possible timeline. Mr. Ford will be attending the January 11, 2024, meeting with more detailed information. Per our contract with Landscape Architects and Planners, Mr. Ford will serve as our "Prime Professional" to design and oversee the construction of the project.

An extensive update was given on the Hayhoe Trail Extension feasibility study. Mr. Ford provided a synopsis of his meeting with the property owners. Discussion followed on possible design routes for the trail.

The Ingham County Trails and Parks Round 8 grant application "phase approach" was explained. The amended grant request for the Vevay Township Community Park Improvement is \$240,000. Mr. Ford will attend the Ingham County Parks Commission meeting on December 11, 2023.

Facebook/Website/Outreach. No action was taken.

<u>Vevay Township December Board Meeting.</u> Chair Cargill will attend the December meeting and express the Commission's appreciation for all the support from the Vevay Township Board, as well as provide an update on the Recreation Passport Grant.

<u>Legacy Tree Donation Policy.</u> A draft policy was provided to each member. Secretary Ruttan asked that each member review the draft policy and provide changes, additions, or deletions to the draft policy at the January meeting.
