At a regular meeting of the Board of Trustees of the Township of Vevay, located in the County of Ingham, State of Michigan, held in the Vevay Township Hall, 780 Eden Road, Mason, MI 48854, on January 17, 2024, at 6:30 p.m.

The following preamble and resolution were offered by McNeilly and supported by Kean:

WHEREAS, the Vevay Township Board of Trustee's previously supported the submission of an application titled Vevay Township Community Park Americans with Disabilities Act (ADA) Improvements to the Michigan Department of Natural Resources Recreation Passport grant for the development of a new park entry, pathways, and additional playground equipment to make the park more ADA accessible; and,

WHEREAS, Vevay Township has been awarded a Recreation Passport Local Development Grant in the amount of \$150,000.00.

WHEREAS, the awarded grant supports the Township's 5-Year approved Parks and Recreation Plan; and,

WHEREAS, the Grant is accepted through the execution of the Michigan Recreation Passport Grant Program Development Project Agreement.

NOW THEREFORE, BE IT RESOLVED, that Vevay Township does hereby accept the terms of the Agreement as received from the Michigan Department of Natural Resources, and that the Vevay Township Board of Trustees does hereby specifically agree, but not by way of limitation, as follows:

- 1. To appropriate all funds necessary to complete the project during the project period and to provide Fifty Thousand (\$50,000) dollars to match the grant authorized by the DEPARTMENT.
- 2. To maintain satisfactory financial accounts, documents, and records to make them available to the DEPARTMENT for auditing at reasonable times.
- 3. To construct the project and provide such funds, services, and materials as may be necessary to satisfy the terms of said Agreement.
- 4. To regulate the use of the facility constructed and reserved under this Agreement to assure the use thereof by the public on equal and reasonable terms.
- 5. To comply with any and all terms of said Agreement including all terms not specifically set forth in the foregoing portions of this Resolution.

BE IT FURTHER RESOLVED, that Resolution #24-01 is hereby adopted effective January 17, 2024.

The following Preamble and Resolution were offered by Lewis and supported by McNeilly.

WHEREAS, pursuant to the authority vested in the Ingham County Treasurer as foreclosing governmental unit under MCL 211.78g(8)(a) the Treasurer has created a Payment Reduction Program to reduce payments of delinquent taxes due from persons who have received a poverty exemption from taxes under MCL 211.7u; and

WHEREAS, the Treasurer has elected to use only one of three possible methods to reduce payments, as described in MCL 211.78g(8)(a)(iii):

Cancel all of the interest, penalties, and fees required to be paid under this act; and

WHEREAS, all the costs of such a cancellation will be borne by Ingham County and not by any city, township, village or other taxing authority; and

WHEREAS, parcels within Vevay Township will, pursuant to MCL 211.78g(10)(b)(ii), only be eligible for this program with the participation of Vevay Township through approval of this resolution; and

WHEREAS, any change in the terms of the Payment Reduction Program will take effect only after approval of an additional resolution;

NOW, THEREFORE BE IT RESOLVED, that the Board of Trustees of Vevay Township, acting pursuant to MCL 211.78g(10)(b)(ii) elects to participate in the Payment Reduction Program for delinquent taxes adopted by the Ingham County Treasurer as described in this resolution; and

BE IT FURTHER RESOLVED, that, as provided by MCL 211.78g(10)(b) the Treasurer is authorized to provide the Ingham County Treasurer with written notice of Vevay Township's participation in the Payment Reduction Program.

Other projects include Municode, Zoning Ordinances priorities, DDA recreation grant match, and code enforcement-civil infraction process.

Clerk Report:

<u>Election Update.</u> Approximately 1,350 Absent Voter Applications were mailed with just under 600 being returned to date. Two Military Overseas ballots were sent. The early voting grant-funded equipment has been received as well as the new Absent Voter Counting Board equipment. Clerk Kean distributed a request for an election inspector compensation increase. A portion of the rate increase is reimbursable. The proposed increases will be discussed at the next Board meeting.

<u>Budget Adjustments – Transfer Authority.</u> Clerk Kean informed the Board of a Budget Authority transfer of \$2,000 from Educational Meetings (GL# 101-101-960.000) to Elections Print/Publish/Postage (GL# 101-262-900.000).

<u>Treasurer Report: General Fund Financial, Revenue Sharing Graph & Tax Collection</u>
<u>Update.</u> Treasurer Lewis provided a comparison tax collection update as well as a review of the General Fund Financial and Revenue Sharing Graphs.
