### WHERE DOES THE MONEY GO?

Many people this year asked me why property taxes are so high. For instance, my property tax bill increased by almost 20% this year, due in large part to the voters of Ingham County and the Mason School District (where I live) over the past two years approving seven tax renewals, increases, or a new millage.

By law, the Township collects real and personal property taxes for every governmental unit that levies a millage (Ingham County, schools) or an assessment (county drains, lighting districts). Some entities are only on your summer bill or your winter bill, and some are on both. Every year Vevay Township collects taxes and assessments for almost 50 purposes: the state education tax, Mason Schools and Dansville Schools tax as well as many special school millages, Ingham County, Potter Park Zoo, the Airport Authority, Farmland Preservation, 9-1-1, Animal Control, and more. Assessments are mostly based on geography and are not paid by every resident, and include over a dozen drainage districts, and three lighting districts.

By law, the Township levies 1.0 mill, and is allowed to assess a 1 percent administrative fee to pay the cost of collecting taxes for so many other entities. Of the over \$6 million collected by Vevay Township in 2019, \$200,377 (3.3%) was for the Township. ### FROM THE ASSESSOR'S OFFICE

Disabled Veteran Exemption. If you are a veteran and are receiving disabled benefits because of your military service, you may be eligible for a property tax exemption. To be eligible the Department of Veterans Affairs must have determined the veteran is 100% disabled or is rated as unemployable due to military service. Disabled veterans should receive a summary of benefits letter from the VA. The benefits letter is usually mailed to veterans in November of each year. If you receive a disability benefit from the VA and have questions about a possible property tax exemption, please call me on Tuesdays.

**2020** Elections Update: It was a monumental election cycle to complete all three 2020 Elections this year; the March Presidential Primary, the August Primary, and the November General Election. Let's begin by sharing some highlights from November's historic Election. First, Vevay Township residents are THE BEST! A BIG thank you to all Vevay voters; your patience and over-whelming positive attitudes were noticed and well received by the office staff, the Election Workers, and by me! YOU make Vevay a desirable place to live ©

The massive voter turnout in Vevay was 74.76% (historic!); with 787 voting on November 3rd and 1,513 voting by absentee/mail-in ballot (historic!). The day began at 7 a.m. with 58 residents in line which continued throughout the day. At the 8 p.m. close, there were still 10 voters waiting (historic!). The shortest wait times ranged from 30 to 45 minutes with the longest times from 60 to 75 minutes. Sixteen of our military and overseas voters cast their ballots by 8 p.m. Election night (historic!). On Elections Day, 16 residents actually registered to vote with the required documentation and then cast their ballot (historic!).

A special shout-out to the Vevay team of Election Workers! This exceptional group executed the game plan, as always with integrity and skill, to create a successful election year. Lastly, it continues to be my privilege to serve as your Clerk as I have since 2010. *Thank you!*

## NEWS FROM THE TREASURER'S OFFICE

Winter taxes will be mailed out the last week of November and can be accepted for payment Dec. 1st, 2020. Winter taxes are due by Friday, February 16, 2021. After Feb 16th, a 4% penalty and interest will be charged. Summer and Winter taxes will be collected in the Treasurer's office thru March 1, 2021, after that date they will be turned over delinquent to the Ingham County Treasurer. Postmarks will not be accepted! Please allow one week for mailing payments. Partial Payments are always accepted. We are encouraging the use of the townships "night drop" box to minimize the chances of in-person contact and to protect our taxpayers. Facemasks and social distancing will be required within the township hall. If you are having difficulty paying your property taxes, please contact the County Treasurers office (517-676-7239) and they can provide you with assistance and resources. If a mortgage company is paying your taxes, you will also receive a copy of your tax bill with a highlighted notation in the upper right-hand corner that says "a copy of your bill has been requested by your mortgage provider". A receipt will be mailed to you only if requested. If you do not receive a tax bill call my office and we will mail or email one to you.

As we have all been dealing with the COVID-19 pandemic some difficult decisions will have to be made regarding the Townships Budget for next fiscal year. For anyone interested, Feb & March are the time of year the Board of Trustees works on the Budgets for the upcoming fiscal year. We encourage residents to participate in this governmental process. All meetings are open to the public and posted on the township's website. Come and see how your government works!
