**WHEREAS**, the Board authorizes the reallocation of Committed Net Assets Building & Grounds Air Conditioner, Townhall Re-siding, and Townhall Re-roof to Vehicles 2006 Pickup Truck \$35,000, SCAG Mower \$3,000, and Unrestricted Net Assets \$27,000; and

**NOW THEREFORE**, be it resolved, that the Board of Trustees of Vevay Township adopts the funding for the 2019-2025 Capital Improvement Plan, as presented in Attachment A; and

**BE IT FURTHER RESOLVED,** that Resolution #23-07 is hereby adopted effective April 1, 2023.
