At a regular meeting of the Township Board of Trustees of the Township of Vevay, Ingham County, Michigan, held in the Township Hall, 780 Eden Road, Mason, Michigan 48854 on the 12th day of April 2023.

The following Preamble and Resolution were offered by McNeilly and supported by Kean.

**WHEREAS**, the Ingham County Trails and Parks Program application requires the governing body of the local unit of government to pass a resolution including the amount of the local match in terms of dollar amount or percentage of total project cost; and

**WHEREAS**, the Vevay Board of Trustees supports the submission of a grant application titled Vevay Township, Hayhoe Trail Extension & Trailhead to the 2023 Ingham County Trails and Parks Program for the development of the Hayhoe Trail extension from Kipp Road to the Vevay Township Hall and new trailhead; and

**WHEREAS**, the proposed application is supported by the Vevay Township's 5-Year Community Parks & Recreation Plan to enhance and increase the quality of life for the residents of Vevay Township; and

**WHEREAS**, the Vevay Board of Trustees is hereby making a financial commitment to the project in the amount of \$30,000 matching funds, in cash and/or in-kind/force amount to come from the Vevay Township's general fund budget.

**NOW, THEREFORE, BE IT RESOLVED**, the Vevay Board of Trustees hereby commits \$30,000 match in cash and/or in-kind/force amount to the 2023 Ingham County Trails and Parks Program grant application titled Vevay Township, Hayhoe Trail Extension and Trailhead; and

**BE IT FURTHER RESOLVED**, the Vevay Township Board of Trustees approves the submission of the 2023 Ingham County Trails & Parks Program grant application titled Vevay Township, Hayhoe Trail Extension & Trailhead.
